Resolutions and Nominations

Resolutions (Item 5):

1. Resolution 1 - Committee Resolution

Amendment to constitution section 8.3.1

Add **Youth Representative** and remove **Bar Manager** so that the list of Management Committee roles reads:

8.3.1 The Management Committee shall consist of a Chair, Deputy Chair, Secretary, Treasurer, Fixture Secretary, Social Secretary, Membership Secretary, Club Safeguarding Officer, Grounds Manager, Youth Manager & Youth Representative.

2. Resolution 2 - Committee Resolution

Amendment to constitution section 4.4 to **remove the 31st March** date and replace it with **31st January** so that it reads:

4.4 Membership of the Club shall be determined by payment of the appropriate Annual Subscription Fee. This fee (including payment for indoor net sessions and expected match fees) must be paid via a monthly standing order started by 31st January at the latest - or paid in full - for the year.

If monthly or full payments are not received by 31st January membership of the Club will be considered terminated until such time as payment is received in full (including any applicable late payment fee).

New members wishing to join the Club after 31st January of the year following the Annual General Meeting, shall be charged an appropriate Annual Subscription Fee at the discretion of the Management Committee.

3. Resolution 3 - Committee Resolution

Membership subscriptions will **remain unchanged** for the 2026 season.

Match fees for league matches will be **increased by £3 per match** for all member categories to pay for the cost of providing teas.

Indoor net fees will be £4 per session for both adults and colts.

If resolution 3 is agreed, then resolutions 4 & 5 will be withdrawn.

4. Resolution 4 - Committee Resolution

Membership subscriptions will **remain unchanged** for the 2026 season.

Match fees for league matches will be **increased by £1 per match** for all member categories to pay for the cost of providing cakes.

Indoor net fees will be £4 per session for both adults and colts. If resolution 4 is agreed, then resolution 5 will be withdrawn.

5. Resolution 5 - Committee Resolution

Current membership subscriptions and match fees will **remain unchanged** for the 2026 season.

Indoor net fees will be £4 per session for both adults and colts.
